At our headquarters in **Stuttgart-Vaihingen**, the logistics center is used to store our system products and single-wire solutions. An automatic high-performance carousel using pick-by-light ensures fast and safe retrieval of the articles. With the logistics and service centers in Ludwigsburg, Stuttgart, Hanover and Wroclaw, U.I. Lapp GmbH has a highly modern and complex logistics system.

---

## **Ludwigsburg logistics Center**

In the Ludwigsburg Logistics Center, cable drums are stored and retrieved fully automatically by storage and retrieval machines in an area of around 30,000 m<sup>2</sup>. A specially developed and patented mandrel gripper enables fast and gentle storage via special system pallets. In addition, modern driverless transport systems bring the cable drums to the cut-to-length machines.

## **Hanover logistics center**

The logistics center in Hanover is equipped with heavy-duty & high-performance machinery for shipping large drums and also has special cutting machines with traction force limitation for the perfect handling of special product groups such as sensitive fiber optic cables.

## **Wroclaw logistics center**

The logistics center in Wroclaw, Poland, mainly stores infrastructure cables with large cross-sections on an area of 60,000 m<sup>2</sup>. Heavy-duty forklifts and special cut-to-length machines are available for the provision and shipment of these heavy infrastructure cables or cable drums.
