The company named above can use this GLN as a basis from which to generate all GS1 identifiers. In particular, this includes both the Global Trade Item Number for products and services (GTIN) and the number of the shipping unit (NVE/SSCC). These identifiers can also be encoded in a machine-readable format using the GS1 data carriers, for example EAN-13, GS1-128, GS1 DataBar, GS1 DataMatrix or an electronic product code in RFID tags (EPC/RFID).

The GS1 standards comply with, among other things, the following international standards:

- **ISO/IEC 15418:** GS1 application identifiers and ASC MH10 - data identifiers and maintenance

- **DIN SPEC 16567:** Model agreement on invoicing with structured electronic data interchange (EDI)
- **DIN SPEC 27003:** Cross company product information networks in consumer goods industry environment - Terminology

They also meet symbology standards covering GS1 codes: EAN/UPC, GS1-128, GS1 DataBar, GS1 DataMatrix, GS1 QR Code.

By using the GS1 system, the conditions required for the cross-company, transnational and industry-wide exchange of data and goods along the supply chain are met.
