

PRIVACY POLICY REGARDING THE PROCESSING OF PERSONAL DATA PURSUANT TO ARTICLE 13 OF REGULATION (EU) 2016/679 - CONTACT REQUEST

Dear user,

we provide the information required by Article 13 of the GDPR regarding the processing of personal data provided for the request for information.

A. Data relative to the Data Controller

The Data Controller is Camuna Cavi S.r.l. ("Camuna"), via General Treboldi n. 128, Edolo (BS) e-mail: titolaredati.cce@camunacavi.it.

B. Data processed

The user can request information from Camuna in the following ways:




- by entering the request in the appropriate "Contact" form on the Camuna website (<https://camunacavi.lappgroup.com/nc/contact.html>);
- contacting by e-mail one of the addresses published in the "Contact Us" section of the aforementioned website (<https://camunacavi.lappgroup.com/contact-us.html>)

Depending on the method chosen by the user, Camuna will process the personal data indicated below (hereinafter "Data"):

- For the request made through the form:
 - title, name, surname, company, department, customer number, address (street, number, postal code, city, country), e-mail, fax, telephone number, purpose and wording of the message;
 - the user's IP address and date and time of transmission of the message.
- For the request sent by e-mail: the personal data transmitted by e-mail by the user.

C. Purpose of the processing, legal basis of the processing and retention period

The Data requested in the "Contact" form will be processed for the purposes indicated below.

Once the above terms have elapsed, your data will be destroyed or anonymised compatibly with the technical deletion and backup procedures.

D. Mandatory provision of data

Pursuant to Article 13, paragraph 2, letter e) of the GDPR, we inform you that the provision of the Data requested in the "Contact" form marked with an asterisk is mandatory. Failing that, Camuna will not be able to process your request.

E. Data recipients

Your data may be communicated to subjects operating as controllers (such as, by way of example, supervisory and control authorities and any public entity entitled to request data if required by law) or processed, on behalf of Camuna, by subjects designated as Processors, to whom adequate operating instructions are given, including UI Lapp GmbH, parent company of Camuna with registered office in Schulze-Delitzsch-Straße 25, 70565 Stuttgart - Germany which provides hosting and website operation services.

F. Subjects authorised to process

The Data may be processed by the employees of the corporate functions appointed to pursue the aforementioned purposes, who have been expressly authorised to process and who have received adequate operating instructions.

G. The Data Subject's rights

By contacting Camuna by e-mail at the address titolaredati.cce@camunacavi.it, the data subjects can ask the data controller for access to their Data, deletion in the cases provided for by Article 17, the correction of inaccurate data, the integration of incomplete data, the limitation of processing in the cases provided for by Article 18 GDPR.

Furthermore, if the processing is based on consent or on the contract and is carried out with automated tools, the Data Subjects have the right to receive the data they provide in a structured and commonly used format that can be read by an automatic device and, if applicable, the right to send them to another controller without hindrance.

The data subjects have the right to withdraw the consent given at any time, as well as to oppose at any time the processing of data carried out for direct marketing purposes, including the profiling connected to it.

In particular, we inform you that, in relation to the promotional communications sent by e-mail, you can object to the processing at any time, easily and free of charge, using the "unsubscribe" function shown at the bottom of each e-mail.

Data subjects have the right to lodge a complaint with the competent Supervisory Authority in the Member State in which they habitually reside or work or in the State in which the alleged violation occurred.
