on compliance with the CE marking requirement in accordance with the Construction Products **Regulation (EU) No. 305/2011** between

1. Preamble

(Manufacturer)

(Distributor)

- 1.1. Construction products are cables within the scope of application of EN 50575:2014 + A1:2016.
- 1.2. The Manufacturer shall keep a list of the order numbers of the construction products marketed by the Manufacturer on the Manufacturer's website.
- 1.3. Construction products shall be sold by the Manufacturer to the Distributor, which shall then resell them.
- 1.4. The contract governs the responsibilities of the Manufacturer and Distributor to comply with the CE marking requirement.

- 2. Obligations of the Manufacturer
 - 2.1. Obligations of the Manufacturer in accordance with REGULATION (EU) No. 305/2011, Article 11.
 - 2.2. The Manufacturer shall make available to the Distributor in German and English the information necessary for CE marking in the correct label format and the Manufacturer's declaration of performance in current and correct form on the Manufacturer's website according to 1.5.
 - 2.3. The Manufacturer undertakes to continuously maintain the Manufacturer's website.
 - 2.4. The Manufacturer shall inform its contractual partner immediately of any changes to the information pursuant to 2.2. at the time of the conclusion of the contract.
 - 2.5. The Manufacturer authorises the Distributor for CE marking of the Manufacturer's construction products according to the information in 2.2.

3. Obligations of the Distributor

- 3.1. Obligations of the Distributor in accordance with REGULATION (EU) No. 305/2011, Article 14.
- 3.2. The Distributor undertakes, taking into consideration the obligations of the Manufacturer pursuant to 2.1., to affix the CE mark in accordance with 2.2. to ensure continuity of the Manufacturer's CE mark prior to resale. This applies if the Manufacturer's CE mark is no longer clearly visible, legible or permanent, or a partial amount of the construction product goes on to be resold. In cases where the Distributor does not fulfil this properly or at all, it shall undertake to indemnify the Manufacturer against all third-party claims (including fines) upon first written request.
- 3.3. The Distributor is prohibited from placing on the market construction products produced by the Manufacturer bearing its own name or its trademark (in addition to or instead of the Manufacturer's trademark) without the Manufacturer's permission (prior consent).
- 3.4. The Distributor undertakes to place and maintain on its website at all times a link (reference) to the Manufacturer's website as stated in 1.5. for the respective construction products.
- 3.5. The Distributor shall always provide the Manufacturer with the opportunity, after appropriate advance notice, to check compliance with the contractual obligations.
- 3.6. The Distributor is hereby appointed as the Manufacturer's authorised representative in accordance with Art. 12 REGULATION (EU) No. 305/2011. Its obligations as the Distributor in accordance with Art. 14 REGULATION (EU) No. 305/11 shall be unaffected by this.
